MINUTES

Anita opened the meeting and welcomed everyone and requested that members review the minutes of the February 23, 2016 meeting. Debra made the motion, seconded by Gene and unanimous vote to approve the minutes.

FINANCIAL REPORT

Scott presented the financial report for February 2016 for review and approval. Gene made the motion, seconded by David and unanimous vote to approve the financial report.

Audit Contract

Danny made the motion, seconded by Gene and unanimous vote to approve the July 1, 2015- June 30, 2016 audit contract from Cannon and Company LLP at a fee of 1500.

Elkin Roots Music Fest

Dr. Blackley spoke about the Elkin Roots Music Fest, May 14, 2016 from 1pm till 8pm at the Elkin Municipal Park. The festival continues to grow in attendance each year and the continued growth depends on the community sponsorship. The Sponsorship levels are: 1,000 Platinum, 500 Gold, 250 Silver, 100 Bronze and 50 Friend. Debra made the motion, seconded by David and unanimous vote to give the 1,000 Platinum level.

Yadkin Navigator

The fee is 750.00 for the Town of Jonesville and the JTDA to advertise in the Yadkin Navigator. David made the motion, seconded by Debra and unanimous vote to split the cost at 375.00 each with the Town of Jonesville.

Jonesville Historical Society

Judy Wolfe informed the Board that the two 250.00 Scholarship (500.00) for the 5K race to be held in conjunction with the Jonesville Jubilee that was approved in the February 23, 2016 JTDA meeting will not be awarded.

Jonesville Greenway

Pat reported that the trail is in good condition and gravel looks good and thanked the Town Maintenance Crew for spreading it. Ron Niland has reapplied for the Grant for the Bridge.

JTDA Board Members Terms Expiring

Debra Clark and Gene Pardue's terms expire on June 30, 2016, Pat made the motion, seconded by David and unanimous vote to recommend to the Town Board that Gene and Debra be appointed to another term.

Shrubs in the 67-I-77 right of way

Scott met with the DOT officials and they have proposed that if the Town will pay for the removal of the old shrubs they will plan and design the same as the agreement on the traffic circle. **(The Contractor will be responsible for maintaining the landscape for 1 year and then it will be the Town's responsibility for maintaining it)**

Gene made the motion, seconded by Bob and unanimous vote to adjourn the meeting.
