The Jonesville Historical Society has proposed that the Town Council adopt the Resolution commemorating the 150th anniversary of the end of the American Civil War that is included behind Tab 2. The Yadkin County Board of Commissioners recently adopted a similar Resolution following a request to do so by the Yadkin County Historical Society and others.

6.) APPOINTMENT OF ABC BOARD REPRESENTATIVES (TAB 3)

As was discussed at a recent workshop meeting, the agreement between Jonesville and Elkin to form a unified ABC system directs that Jonesville appoint two members to the new Yadkin Valley ABC Board. These first two appointments will be one for one year and one for two years. After these first appointments all future appointments will be for three years.

For review, the following persons have been mentioned and/or expressed a desire to serve on the ABC Board: Issy Hinshaw, Regina Adkins, Neil Finger, James Gillespie, Phil Stallard and Phyllis Salley. Town staff has spoken with each of these individuals and they all have agreed to serve if selected to do so.

For review, the Council needs to appoint one person for a one year term and one person for a two year term.
