

**MINUTES  
MAY 11, 2015**

**REGULAR MEETING  
7:00pm**

Mayor Pardue and all Council Members were present.

Mayor Pardue called the meeting to order and led the invocation followed by the Pledge of Allegiance.

**PUBLIC FORUM**

Judy Wolfe thanked everyone for their support in helping with the Jubilee be a success. The fireworks once again were amazing. She presented departments with certificates of appreciation. Coming up events and dates are listed on the website.

**APPROVAL OF MINUTES**

Council Member Moore made the motion to approve the minutes from the regular meeting April 13, 2015 and the budget workshop minutes April 27, 2015 and Council Member Wall seconded the motion, passed unanimous 4-0.

**PRESENTATION – DR. WILLIAM BLACKLEY**

Dr. William (Bill) Blackley was at the meeting to discuss the regional trail system that the Elkin Valley Trails Association has been working on. Dr. Blackley presented a Powerpoint presentation for the Board proposing that both sides of the county boundaries work together to create awareness of our mutual history, develop common trails for various recreation activities, work hand in hand to build segments of the Mountain to Sea Trail, and work jointly to improve our Watershed Now concept for both water systems.

**RESOLUTION COMMENORATING THE END OF THE CIVIL WAR**

The Jonesville Historical Society has proposed that the Town Council adopt the Resolution commemorating the 150<sup>th</sup> anniversary of the end of the American Civil War. The Yadkin County Board of Commissioners recently adopted a similar Resolution following a request to do so by the Yadkin County Historical Society and others.

Council Member Green made the motion to approve the resolution for commemorating the 150<sup>th</sup> anniversary of the end of the American Civil War and Council Member Moore seconded the motion, passed unanimous 4-0.

## **APPOINTMENT OF ABC BOARD REPRESENTATIVES**

As was discussed at a recent workshop meeting, the agreement between Jonesville and Elkin to form a unified ABC system directs that Jonesville appoint two members to the new Yadkin Valley ABC Board. These first two appointments will be one for one year and one for two years. After these first appointments all future appointments will be for three years.

For review, the following persons have been mentioned and/or expressed a desire to serve on the ABC Board: Issy Hinshaw, Regina Adkins, Neil Finger, James Gillespie, Phil Stallard and Phyllis Salley. Town staff has spoken with each of these individuals and they all have agreed to serve if selected to do so.

For review, the Council needs to appoint one person for a one year term and one person for a two year term.

Phil Stallard called back and wanted to be removed from the list.

Council Member Moore made the motion to approve Regina Adkins for the one year term and Council Member Wall seconded the motion, passed unanimous 4-0.

Council Member Moore made the motion to approve James Gillespie for the two year term and Council Member Darnell seconded the motion, passed unanimous 4-0.

## **SET DATE FOR BUDGET PUBLIC HEARING**

Council Member Green made the motion to set the budget public hearing June 8, 2015 and Council Member Wall, seconded the motion, passed unanimous 4-0.

## **RESOLUTION DECLARING SURPLUS PROPERTY**

The Town has listed several items that are surplus for you to review, Council will need to make a motion to the resolution declaring these items as surplus, so they can be sold.

Council Member Moore made the motion to approve the resolution for the surplus items to be sold and Council Member Green, seconded the motion, passed unanimous 4-0.

## **DEPARTMENTAL REPORTS**

We have two tax bills that need to be released. Both have outstanding balances of less than one dollar (\$1.00) and; therefore, would cost more to attempt to collect than the amount owed.

Council Member Wall made the motion to release these taxes under \$1.00 and Council Member Darnell seconded the motion, passed unanimous 4-0.

The departmental reports are included in your agenda packet. The Council will need to make a motion to approve the monthly financial report.

Council Member Moore made the motion to approve the financial reports and Council Member Darnell, seconded the motion, passed unanimous 4-0.

With no pending business to discuss Council Member Darnell made the motion to adjourn and Council Member Wall, seconded the motion, passed unanimous 4-0.
